Welcome to United to END FGM (UEFGM)

United to END FGM (UEFGM) is a free-of-charge e-learning tool, offering information and practical advice about female genital mutilation (FGM).

Primarily designed for health and asylum service staff working in Europe, the course will also be of use to NGOs, including women's organisations and shelters. The UEFGM course has three main aims:

01

To improve the support and treatment offered to women and girls in Europe living with or at risk

of genital mutilation, by encouraging a more specialised gender- and culture-sensitive approach in the healthcare services.



To strengthen the skills needed to maintain a high standard of decision-making in protecting

FGM-affected and/or at-risk women and gi rls seeking asylum.



To bring about the greater harmonisation of the European Asylum System, by highlighting

relevant European and international treaties and legislation protecting FGM-affected and/or at-risk women and girls.



Design and develop an **integrated website** that will host the knowledge platform including the <u>e-learning course</u>, <u>'live knowledge' features</u> and <u>country information pages</u>.

- 6. The Asylum Context: Communication and Interviewing Techniques (focuses on techniques of effective communication with women/girls affected by FGM)
- 7. The role of the justice system in ending FGM
- 8. The Role of Police in ending FGM

- **10**. FGM and Child Protection
- **11**. The Role of the Education Sector in Preventing FGM
- **12**. Community Based Approach in Responding to FGM

13. Communicating and Reporting about FGM
