


**Egypt: MTV Brings New Drama to Egypt Tackling FGM**

Under a series of new laws signed Tuesday, Michigan became the 26th state to place a criminal ban on female genital mutilation. While the United States' federal legislation may appear sufficient on the surface, Parker explained that in states without their own laws, FGM allegations often get swept under the rug.
