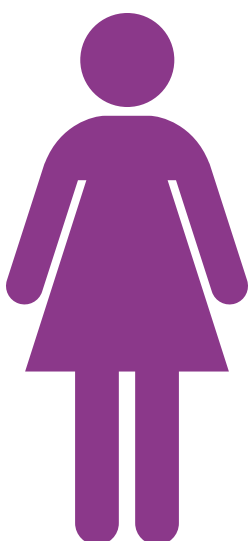


# SUPPORT FOR VICTIMS OF FEMALE GENITAL MUTILATION/VIOLENCE AGAINST WOMEN & GIRLS



## FGM = VAWG

Female Genital Mutilation is defined as a form of Violence Against Women and Girls (VAWG) in accordance with the 2011 Council of Europe Convention on preventing and combating violence against women and domestic violence.



## FGM SURVIVORS ARE VICTIMS OF VAWG



Women and girls who are survivors of FGM are also victims of violence against women and girls. As a female victim of VAWG you are protected by EU and international law.



## VICTIMS OF VAWG HAVE RIGHTS



Any persons who fall into the legal definition as a victim of violence against women and girls is victim of crime and has a number of rights under the EU including the right to support and are entitled to access victim support services .



## WHAT ARE YOUR RIGHTS AS A VICTIM OF VAWG ?

Victim support services must:

- Inform victims of their rights
- Provide procedural and practical information
- Provide referrals to specialist services
- Receive emotional support



Victims have the rights to confidential, free support, whether they reported the crime or not, irrelevant of their residence status.

Persons experiencing these issues are entitled to free information, advice, emotional, psychological and practical support from their local health services. 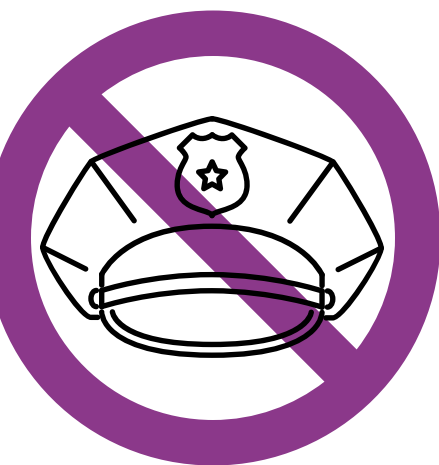
WHERE CAN I FIND AN NGO CLOSE TO ME FOR REFERRAL ?

For any information concerning access to such services, interested persons are invited to contact the End FGM European Network and its partner organisations.



CAN THE POLICE HELP ME GET SUPPORT ?

Yes. The EU member states are obliged to facilitate the referral of victims to support services.



I DO NOT WANT TO LODGE A COMPLAINT WITH THE POLICE. AM I STILL ENTITLED TO ACCESS VICTIM SUPPORT SERVICES ?

Yes. FGM survivors are not obliged to file a formal complaint in order to have access to victim support services.
