A WORD FROM THE CO-PRESIDENTS

Dear friends, supporters and colleagues,

In June of this year, we were honoured to be elected as co-presidents of the End FGM European Network. As co-presidents, we are focused on the continued development of the Network. In collaboration with members, we look forward to taking the organisation to the next phase of its development, by building on the years of invaluable work and passion of the previous board. We wish to thank our funders, supporters, secretariat staff and members for their commitment and dedication to ending FGM.

In this annual report, we, the members of the End FGM European Network, reflect on the year that was. 2018 has been an exceptionally busy and positive year for the Network, with internal changes, as well as increased activities. In 2018, the Network began to implement a new strategic plan – the fruit of a participatory process driven by our members. In the coming years the Network is committed to strengthening the European and global movement to end FGM, while ensuring the voices of affected communities, young people and survivors of FGM remain at the heart of our work.

In 2018, the Network implemented a diverse number of activities over the course of the vear including two regional conferences, the launch of a capacity building programme and several trainings for members. A big focus remained on raising awareness on FGM as a global issue and as a European issue. In February 2018 the #Mvissuetoo campaign was launched. This campaign caused a social media storm with activities taking place across European countries. An indicator of the success of this campaign, was the unanticipated global reach with numerous activities in Canada and Africa.

The Network continued to push a building bridges approach, highlighting the importance of connecting regions, sectors and actors. To this end in 2018, with our counterparts in the other regions in the world we formally established an Inter-Regional Coalition to end FGM. The coalition issued its first joint statement in November.

Through our 'Youth Hub' we further invested in young activists by building their capacity and giving them opportunities to make their voices heard. In 2018, these young people spoke at European Parliament committees and met numerous political leaders. The future looks bright with such engaged, articulate and passionate young leaders.

There was significant change within the secretariat of the End FGM European Network – particularly with the recruitment of the new Director. Fiona Coyle.

The Network also expanded by three new members. We would like to personally welcome all who are new to the Network. We believe that with your support and input we will grow from strength to strength.

2018 was marked by the willingness and energy of our members to collaborate around learning, best practice and impact In 2018, the Network introduced platforms for members to exchange, share expertise and best practice, and formulate Network positions to influence governmental and institutional decision-making. This collective work resulted in position papers on Community engagement, Medicalisation of FGM. Research priorities and Building bridges. In 2019, the Network will continue to bring members together across existing and new thematic areas, to stimulate learning and ensure practical application of lessons learnt.

Finally, we know that in the coming year European elections will take place, which will provide us with an opportunity to set the European agenda for many years to come. The past European legislature has paid an increasing attention to the issue of violence against women and girls, gender equality and ending FGM both in Europe and beyond. But there is still a lot to be done, and now is the time to walk the extra mile and scale up those commitments and actions, to make sure to deliver a more egual world free from violence to the future generations. Through our EU elections campaign, the Network will work to ensure that FGM remains at the heart of the EU



KEY ACHIEVEMENTS

- → Ensured that the cross-border dimension of FGM is addressed in key policy processes :
 - Resolution on FGM by the **European Parliament** on the 7th of February 2018
 - Human Rights Council 38th session Resolution on eliminating FGM
 - UN Secretary General report on "intensifying global efforts for the elimination of female genital mutilation"
 - Resolution on FGM by the **UN General Assembly** on the 14th of November 2018
- Strengthened community participation in relevant international processes, through involving young people and community ambassadors in 12 key dialogues, at European and international levels
- Members worked together to develop 4 position papers
- Established an Inter-Regional Coalition to end FGM, strengthening cross-border cooperation with regional counterparts in Africa, Asia and the US
- Developed and promulgated an **empowering narrative** on FGM in Europe, including training of members, partners and the media
- Promoted and advocated for professionals to receive training on FGM:
 - disseminated with the help of our members the **United to End FGM platform** (UEFGM), which was accessed by 110,000 people
 - Over **6197 professionals were trained** at national level by the members of the Network
- Built a consensus on the need to holistically address the global nature of FGM, through 2 international conferences
- Formalised the championship and support of over 100 policy makers and politicians



Our members successfully influenced policy at national level and secured several important changes:

- Portugal: start of a national advocacy group to establish key specific instruments to end FGM and support affected communities
- Belgium: a law was voted on the obligation of doctors to record FGM cases
- Spain: the Inter-Parties National Agreement against gender-based violence included the issue of FGM in for the first time
- Finland: a new multiannual National Action Plan on **FGM** was adopted

EUROPEAN LEVEL

- Adoption of a European Parliament resolution on FGM on 7 February 2018 reflecting all our core asks and mentioning the importance of the Network and #MylssueToo campaign, gave unprecedented visibility to the issue of FGM at European institutional level
- Roundtable to mark the 5-year anniversary on the adoption of the comprehensive European Commission's Action Plan on eliminating FGM in Europe and globally, which brought together actors from several sectors (EU, NGOs, Member States, community voices) who came up with key actions
- Over 30 meetings with policy makers and political representatives held by the Network. Increasing adequate policies and ensuring their implementation



EUROPEAN WEEK OF ACTION FOR

YOUTH ADVOCACY WORKSHOP

- Submission of 5 shadow reports on the **Istanbul Convention**. 7 Members in five countries submitted, under the Network's coordination, joint Shadow Reports to the Council of Europe GREVIO Committee, analysing the implementation of the Istanbul Convention in their respective countries and providing key recommendations
- Setting of European Development Days Lab Session on "Building bridges between regions and people - The

INTERNATIONAL LEVEL

- Founding an Inter-Regional Coalition to end FGM. The End FGM European Network brought together anti-FGM networks from Africa. Asia and the US to establish an informal space to share information and work collaboratively. The Coalition held its first meeting and issued its first statement within the 16 days of activism against gender-based violence and held its first meeting aimed at speaking with a united voice to end FGM
- Adoption of a Human Rights Council resolution on FGM in June, which included an emphasis on "migration and other population movements" allowing to take into consideration an important growing context
- Incorporating our input in the UN Secretary General report on "Intensifying global efforts for the elimination of female genital mutilation", which led to the adoption of a **UN General Assembly** resolution on FGM on the 14th of November 2018

#MYISSUETOO CAMPAIGN

- Massive engagement of over 100 key European decision makers such as Members of European Parliament, Commissioners, the EU Special Representative for Human Rights and members of the Council of Europe who wore specifically-made T-shirts
- The key words "My Issue Too" were used in speeches during the plenary debate in the European Parliament, giving visibility to the long-term advocacy work done in the last years. The campaign also reached other regions of the world such as in Canada where the hashtag was shared by school classes raising awareness about FGM for children
- → A campaign video was viewed by thousands online

Combatted the lack of knowledge of the existence of FGM in Europe, by raising public awareness with:

OUR PROGRAMMES



Survivors and members of FGM-affected communities must lead on activities related to them and based on their specific and selfdefined needs. Community voices must play a more central role in all actions and decisions moving forward, if we are to see an end to FGM.

YOUTH AMBASSADORS

Youth activists shared their experiences at several European and international events, including hearings in the European Parliament:

- 1 face-to-face meeting in September where the Youth ambassadors learnt how to conduct advocacy towards the European Parliament and strengthened their knowledge about FGM
- 3 new ambassadors from France and the UK
- The Youth Ambassadors were very active and spoke at conferences, participated in advocacy workshops, met European Union representatives and organised events in their respective countries on FGM and the importance of youth engagement

- 1 face-to-face meeting in April allowed the Ambassadors to connect, review the programme and discuss further development strategies
- Advocacy meetings of the Ambassadors with members of the European Parliament and of the European Commission helped strengthening the voice of those affected by FGM at EU level
- The Ambassadors participated in 10 activities and talked at conferences and events to bring the voices of the affected communities and survivors at the heart of European and international conversations



PROJECTS

CHANGE PLUS CHANGE CHANGE CHANGE



The CHANGE Plus project came to an end in 2018. This was a successful 8-partner project, coordinated by the Network member TERRE DES FEMMES, aiming at encouraging the abandonment of FGM in practicing African communities in Germany, the Netherlands, Portugal and France. One of its main achievements included the promotion of a behavioural CHANGE model. This integrated community voices into the debates on FGM by offering the possibility of direct participation of 'CHANGE Agents' from practising communities through trainings, mentoring and activities.

GENDER ABC Gender



In 2018 the two-year European project Gender ABC was launched, in four European countries lacking gender-related education programmes in schools: Germany, Italy, Spain and Portugal.

The main objectives of the project are:

- > Empowering children in learning about human rights, identifying violations of children rights & forms of genderbased violence and protecting themselves
- Raising awareness of school personnel, families, communities and support services in order to develop safe environments for children
- Strengthening political commitment of local authorities (education, welfare, youth) to sustain school educational programmes on gender-equality
