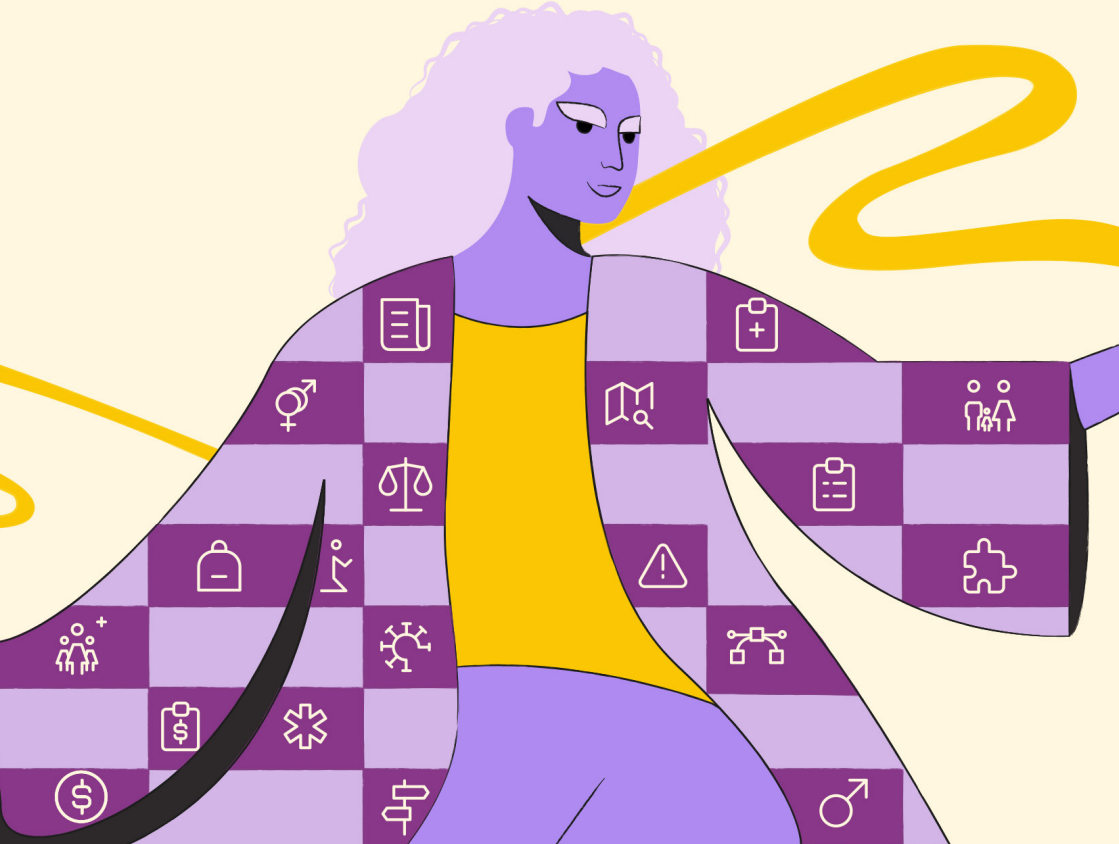

# FOREWORD

Dear members, ambassadors, partners, supporters, and friends, as End FGM EU marks its 10th anniversary, we stand at a pivotal moment of reflection, growth, and renewed dedication. Over the past decade, this Network has been a strong, united voice in the movement to end Female Genital Mutilation (FGM) across Europe and beyond. Our collective efforts, rooted in the unwavering commitment of our members, partners, ambassadors, and allies, have paved the way for meaningful change from raising awareness and influencing policy to supporting survivors and FGM-affected communities.

At the End FGM European Network, we are guided by a profound conviction: a world free of all forms of Female Genital Mutilation, where women and girls are empowered and can fully enjoy their human rights. For over a decade, this belief has fuelled a powerful, collective movement to end FGM.

Founded in 2014, and building on the momentum of Amnesty International's 2009–2014 campaign, our Network has transformed advocacy into action, and action into lasting impact. As we mark a decade of determined mobilisation, we reflect on our achievements and recommit ourselves to the journey ahead.

## Over the past ten years:

- With 39 member organisations across 16 countries, our Network is driving community-based, survivor-centred action from the grassroots to institutions.
- More than 10,000 professionals have been trained across Europe, strengthening care, protection, and legal pathways for FGM survivors.
- Developed Europe's first interactive map on FGM laws and policies: a groundbreaking tool that shapes EU-wide advocacy and increases visibility.
- Through campaigns such as #MyIssueToo, #EndFGM4All, and #BehindEndingFGM, we have reached thousands across borders, challenging stigma and promoting intersectional understanding.
- Influenced landmark policy shifts, including the EU Gender Equality Strategy (2020–2025), the EU Directive on Combating Violence Against Women (2024), and EU accession to the Istanbul Convention.
- Elevated youth voices through innovative, youth-led projects driving systemic change.
- Contributed to 14 major resolutions and strategies, securing FGM's place within EU and international human rights frameworks.

Yet, numbers alone cannot capture the full story. Every policy won, every voice amplified, and every survivor empowered brings us closer to a future where no girl is subjected to this harmful practice.

Ending FGM requires a holistic and intersectional approach. That is why, at End FGM EU, we work to: Strengthen the engagement and capacity of policymakers, professionals, and stakeholders to develop effective prevention, protection, and prosecution mechanisms; Empower communities and grassroots NGOs/CSOs to lead change, recognising the expertise of those most affected; Foster citizen involvement through non-stigmatising, empowering communications that build understanding and solidarity; Monitor and support the implementation of national, EU, and international commitments, ensuring accountability and sustained progress.

This strategy enables us to build bridges across sectors, countries, generations, and lived experiences, cementing End FGM EU as a vital force in the European and global movement to end gender-based violence. Looking Ahead...

The European and global context remains challenging. Humanitarian crises, rising populism, digital misinformation, and entrenched patriarchal norms continue to threaten hard-won rights. Yet, we remain steadfast in our belief that true gender equality, grounded in human rights and community empowerment, is the foundation of sustainability and shared prosperity.

Despite our progress, the statistics remain alarming:

Over 600,000 women are living with the consequences of FGM in Europe, and 190,000 girls and women are at risk across 16 European countries. In recent years, UNHCR estimates that 20,000 women and girls seeking asylum in Europe each year may be affected by FGM. These numbers are a stark reminder of the challenges we still face challenges only compounded by global crises that risk reversing the gains we have made. As you explore this 10-year impact report, you will witness what collective vision, tireless advocacy, and deeprooted collaboration can achieve. But our work is far from over. Let this ten-year anniversary be more than a celebration of past achievements: let it serve as a renewed and urgent call to action for the next decade, to continue shaping a world free from FGM, where every woman and girl can live free from violence and discrimination.

Together, we must continue to collaborate across countries and sectors, and to amplify the voices of survivors, youth, and affected communities placing them at the centre of decision-making and building a future free from FGM.

To our members, partners, ambassadors, professionals, FGM survivors, and supporters: thank you. Our determination fuels this movement, and your solidarity is shaping a future where FGM has no place. As we look to the next decade, it calls on all of us to continue to come together with renewed energy and shared commitment.

## WHO WE ARE

The End FGM European Network (End FGM EU) is an umbrella network of 39 European organisations based in 16 European countries operating to sustain European action to ending female genital mutilation by connecting grassroots communities with non-government organisations. The Network strives to build bridges and cooperation's with all relevant actors in the field of FGM both in Europe and globally. Platforming community voices to influence European governments and policy makers to work towards the elimination of FGM.

End FGM EU operates as a meeting ground for communities, NGOs, CSOs and EU level stakeholders to engage, interact and cooperate with one another by sharing experiences and exchanging knowledge. of The End FGM European Network (End FGM EU) is a world free of all forms of Female Genital Mutilation where women and girls are empowered and can fully enjoy their human rights.

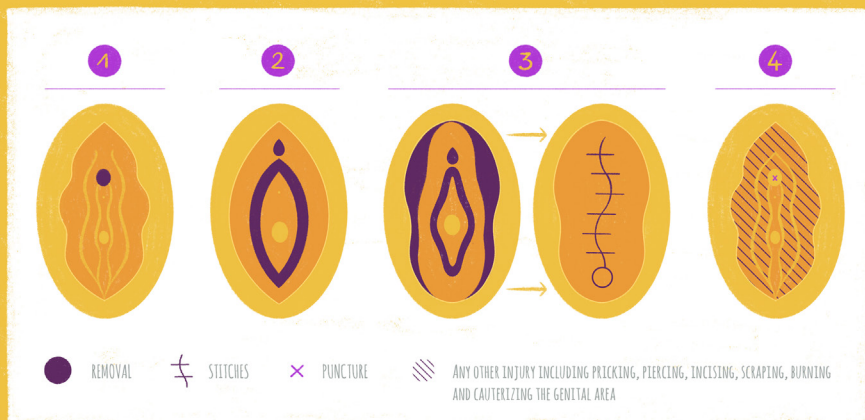
## THE MISSION

## THE TYPES OF FGM: ARE SOME TYPES MORE HARMFUL THAN OTHERS?



ALL FORMS OF FGM ARE EQUALLY HARMFUL TO WOMEN AND GIRLS. ALL TYPES OF FGM HAVE PHYSICAL, PSYCHOLOGICAL AND EMOTIONAL CONSEQUENCES AND A LONG-LASTING IMPACT ON THE LIFE OF SURVIVORS. IT IS INCORRECT TO TALK ABOUT MORE OR LESS HARMFUL TYPES OF FGM BECAUSE THERE IS NO HIERARCHY OR MEASURE OF PAIN AND TRAUMA. THESE COMPARISONS OF HARMFULNESS ONLY RISK INVALIDATING THE EXPERIENCE OF SURVIVORS.

### FEMALE GENITAL MUTILATION IS CLASSIFIED INTO FOUR TYPES

1 Also known as **clitoridectomy**, this type consists of partial or total removal of the external part of the clitoris and/or its prepuce.

2 Also known as **excision**, the external part of clitoris and labia minora are partially or totally removed, with or without excision of the labia majora.

3 It is also known as **infibulation** or pharaonic type. The procedure consists of narrowing the vaginal orifice with creation of a covering seal by cutting and appositioning the labia minora and/or labia majora, with or without removal of the external part of clitoris. The appositioning of the wound edges consists of stitching or holding the cut areas together for a certain period of time (for example, girls' legs are bound together), to create the covering seal. A small opening is left for urine and menstrual blood to escape.

4 This type consists of **all other procedures** to the genitalia of women for non-medical purposes, such as pricking, piercing, incising, scraping and cauterization.

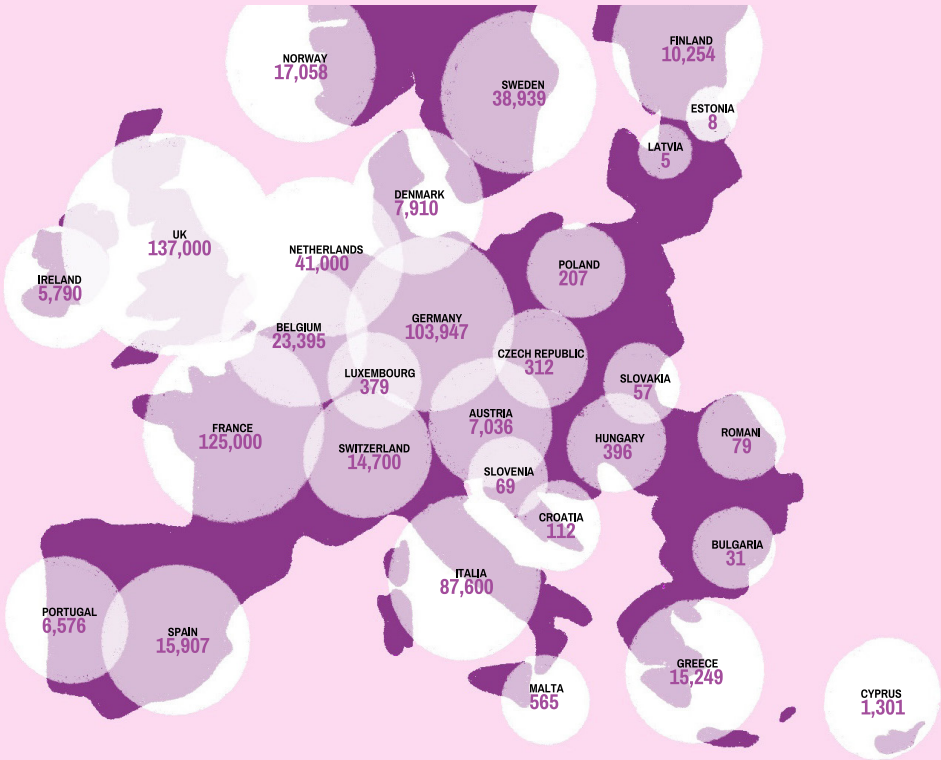

Over 230 million women and girls alive today have undergone FGM (updated figure from UNICEF in 2024) and **4.4 million are projected to be at risk in 2025 (UNFPA)**. It is estimated that there are over 600.000 FGM survivors living in Europe and around 190.000 are at risk in 17 countries alone

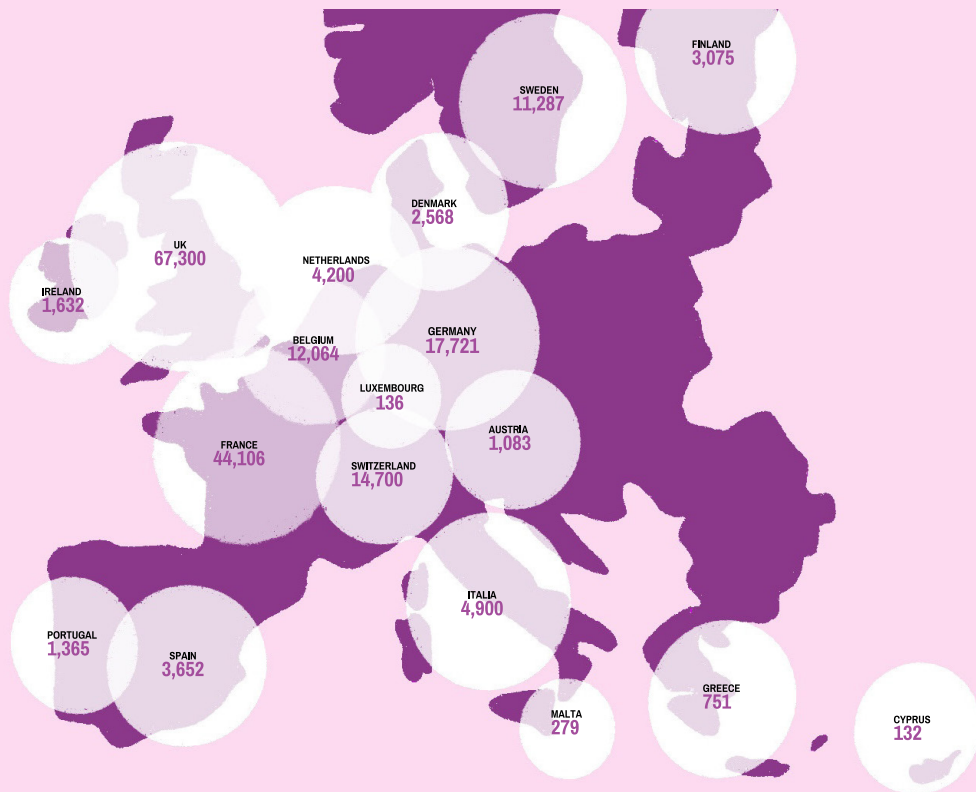
## FGM IN EUROPE

It is important to note that the methodologies and data collection periods differ among these studies, and they cover a different range of age groups. The data is compiled from the most current sources available and is continuously updated by End FGM EU and our national members. However, collecting accurate data remains a significant challenge due to the lack of systematic data collection across European countries making it more difficult to understand the impact of FGM in Europe and better tailor policies, impacting the

# HOW THE END FGM EUROPEAN NETWORK (END FGM EU) WAS BORN

The End FGM European Network (End FGM EU) was founded with the goal of mobilising civil society to fight against FGM across Europe and beyond.

**End FGM European Network** was created following the success of Amnesty International's 2009-2014 End Female Genital Mutilation (FGM) European Campaign.



## KEY FACTS:

**Involved:** 16 civil society organisations across 13 EU Member States.

**Impact:** Raised awareness of FGM in Europe, attracting attention from major institutions like the EU, Council of Europe, and UN.

## ACHIEVEMENTS OF THIS FIVE YEARS CAMPAIGN (2009-2014):

**2011:** Istanbul Convention adopted by the Council of Europe, officially acknowledging FGM as a form of violence against women (VAW). Came into effect in August 2014.

**2012:** Public mobilisation across 13 countries, collecting 42,000 signatures to urge the EU to adopt a strategy to end FGM.

**2013:** European political strategy established toward the elimination of FGM.

**2014:** Political mobilisation and commitments by decision-makers to end FGM. Funding allocated by the European Parliament and European Commission for FGM-related projects.

## Advocacy for the Istanbul Convention:

Engaged in advocacy to push the EU to ratify the Istanbul Convention on violence against women.

**Advocacy to mainstream FGM in several EU policy and legislation** with a focus on asylum (Asylum Directives Guide on FGM in the EU asylum directives, in conjunction with UNHCR, the Council of Europe and a gender expert.) and victims rights (Victims' Rights Directive) Q&A on the Victims' Rights Directive in conjunction with our Belgian member INTACT and a gender expert.

# FOCUS ON ASYLUM

## Ambassadors Program Launch

The Ambassadors Program aims to increase understanding of Female Genital Mutilation (FGM) by sharing personal stories and empowering affected communities across Europe and beyond.



### KEY FOCUS:

Development and monitoring of policies related to FGM and violence against women and girls (VAWG).

Training of FGM-affected communities, including survivors, girls at risk, and men, as advocates for change.



### EXPLORE MORE:

## First European Knowledge Platform for Professionals dealing with female Genital Mutilation (UEFGM):

A web-based resource aimed at improving public and professional knowledge on FGM for various sectors, including health, law enforcement, social services, media and education. The project ended due to a lack of sustainability mechanisms. This highlighted a critical lesson: sustainable funding and institutional ownership are essential for the longevity of digital tools, a principle we now apply to our new END FGM E-Campus platform.



*The European Parliament adopted a resolution calling for a comprehensive EU approach to combat FGM, emphasising the need for prevention, protection, and support for victims.*

# BUILDING BRIDGES BETWEEN EU INTERNAL AND EXTERNAL ACTION TO END FGM

## KEY POINTS:

**Cooperation between stakeholders** in both EU countries of residence and countries of origin for implementing effective actions, policies, and legal frameworks to eliminate FGM.

### **Empowering Youth and Affected Communities:**

The network actively engages young people from FGM-affected communities through the Youth Programme Meeting, which empowers youth to influence the network's advocacy and awareness efforts.

Sustainable Connection between Youth and Affected Communities with EU decision-makers in eliminating FGM in Europe.

**Advocacy to ensure that the cross-border dimension of FGM is addressed in key policy processes:**

**Resolution on FGM by the European Parliament on the 7th of February 2018.** It called for increased efforts from the Commission and Member States to build bridges, strengthen community engagement, mainstream FGM and ensure the highest standards of international protection for FGM survivors coming to Europe.

### Advocacy for the Victims' Rights Directive:

Contributed to revisions of the EU Victims' Rights Directive, focusing on protecting FGM survivors.

### Promoted and advocated for professionals to receive training on FGM:

Disseminated with the help of our members the United to End FGM platform (UEFGM), which was accessed by 110,000 people. This action created a multiplier effect, leading to over 6,197 professionals equipped to provide survivor-centred care across Europe.



### Gender ABC Project:

A two-year initiative aimed at transforming children's attitudes towards gender stereotypes and norms, which are the root causes of harmful practices and gender-based violence.

Focused on amplifying community voices in the FGM movement, with a youth manifesto advocating for increased youth involvement.

# OFFICIAL LAUNCH OF THE FGM INTERACTIVE MAP

## Launch of the FGM Interactive Map in Europe:

This key tool for advocacy highlights FGM laws and policies across 14 European countries. The Interactive Map has become a key reference for policymakers, researchers, and journalists, cited in numerous reports and debates, making the legal and policy landscape of FGM in Europe transparent and accessible.



**Adoption of a European Parliament Resolution on an EU strategy to put an end to FGM around the world**, with key contribution from End FGM EU, calling upon the EU to ensure FGM is included in all EU policy processes

**Launch of the European Commission's Gender Equality Strategy 2020-2025**, planning a revision of the EU Communication on eliminating FGM and the drafting and adoption of a new EU Recommendation on Harmful Practices, including FGM.



**Publication of the United Nations Secretary-General progress Report on Intensifying global efforts for the elimination of Female Genital Mutilation.** It explicitly mentions a report by the End FGM European Network and partners within the Global Platform for Action to end FGM.

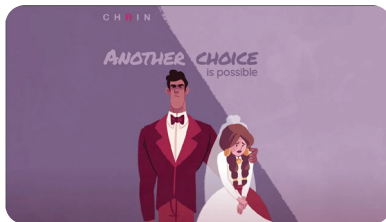

# #ENDFGM4ALL CAMPAIGN

## #EndFGM4All Campaign:

Worked on integrating and promoting and intersectional approach to elimination of FGM and GBV by addressing the complexity of the root causes and intertwined forms of discrimination that play a role in its continuation.

This campaign played a crucial role in breaking down barriers, moving the conversation beyond isolated issues to highlight how FGM is intertwined with discrimination based on race, religion, migration status, class...



The **CHAIN project** through which we created and launched an EU-wide awareness raising campaign on Early and Forced Marriage and FGM.



## Launch of training for healthcare professionals.

Trained over 90 professionals (at the national and EU level) and organised the event ***“Where do we stand with Reconstructive Surgery after FGM in Europe?”*** with 12 European medical professionals to discuss reconstructive surgery practices.

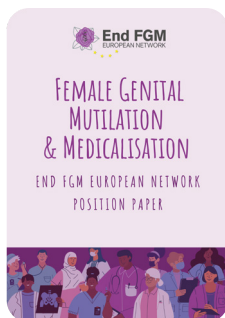

## A Roadmap to End FGM

It highlighted promising practices in Europe, focusing on FGM laws, policies, and personal stories of those involved in the movement. The campaign aimed to inform policymakers, stakeholders, and the public on concrete steps to eliminate FGM.

### KEY FACTS:

#### EU Accession to the Istanbul Convention:

A major achievement in the elimination of FGM, as the EU officially joined the Convention on Violence against Women a major step toward eradicating Female Genital Mutilation (FGM).

#### Global Platform for Action to End FGM/C:

FGM/C: the Network and its global partners organised a global pre-conference at Women Deliver2023 brought together NGOs and survivor-led organisations to strengthen international cooperation to eliminate FGM.



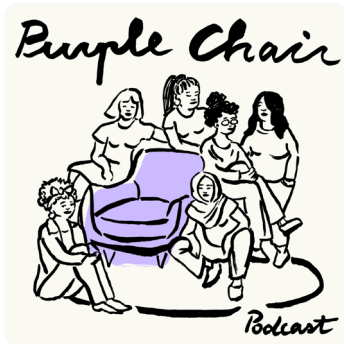

# CELEBRATING A DECADE OF ACTION

## #FGMisPatriarchy

In 2024, the End FGM European Network focus on the patriarchal roots of FGM, emphasising its tangible and symbolic impact on women and girls. The campaign highlights that FGM, present on all continents, is a global expression of patriarchal oppression, affecting women and girls everywhere. This campaign names and challenges the patriarchal systems that perpetuate FGM and all forms of violence against women and girls.



## Launch of the End FGM E-Campus Platform:

A European Knowledge Platform designed to support FGM survivors. This free, multilingual online platform offers practical skills to professionals working with FGM survivors and those at risk. Available in English, French, Greek, Italian, and Portuguese, it provides essential tools and knowledge for delivering appropriate care, contributing to the elimination of FGM in Europe and beyond.



## Adoption of the EU Directive on Combating Violence Against Women (2024):

In May 2024, the EU adopted a crucial directive reaffirming the ban on FGM as a form of gender-based violence (GBV).

### EU Elections 2024:

The 2024 EU elections marked the end of the five-year legislature. It was a crucial moment for the End FGM European Network to engage with candidates and newly elected MEPs. The Network launched an election campaign, preparing a Manifesto outlining key principles for the elimination of FGM. This successful advocacy ensures that FGM remains on the EU agenda for the next legislative term.

# PARTNERSHIPS AND COLLABORATIONS TO ADVANCE THE NETWORK MISSION.

## Key initiatives



### European Week of Action for Girls (EWAG):

A week-long series of EU-level events and meetings focused on celebrating the International Day of the Girl Child (October 11). This coalition brings youth advocates into direct contact with EU decision-makers, promoting girls' rights on a global scale.



## Global Partnerships:

END FGM EU collaborates with the Global Platform for Action to End FGM/C, playing a significant role as a civil society interlocutor, especially within the FGM Donors Working Group. These collaborations emphasise advocacy and knowledge-sharing at both global and EU levels.



## Coalitions:

END FGM EU partners with other coalitions like HRDN, SDG Watch, EU SRHR, EWAG, CSE, and OII Europe, and others. These partnerships help to coordinate actions and push for stronger protections through EU legislation.



# LOOKING AHEAD: PRIORITIES FOR THE NEXT DECADE

Over the past ten years, we have supported policy change, empowered FGM survivors, trained professionals, and reshaped public discourse on FGM. **Together, we have proven that it is possible to build a future where no girl or woman must endure this form of violence.**

A decade of advocacy has shown that only a united, intersectional, and community-led approach can dismantle the deeply rooted practice of FGM. Our next challenge is to secure sustainable resources, deepen grassroots empowerment, and engage policy beyond rhetoric — towards real, measurable social impact.

As we enter the next decade, our members have highlighted key priorities to guide our collective mission:

1. Secure sustainable funding to ensure continuity and long-term impact
2. Empower youth to become leaders of change
3. Expand holistic support for FGM survivors, with dedicated care centres and aftercare services
4. Strengthen advocacy and policy enforcement at EU level, building on gender equality legislation
5. Promote innovation and capacity-building, through our multilingual END FGM E-Campus platform, tailored trainings, and grassroots empowerment.

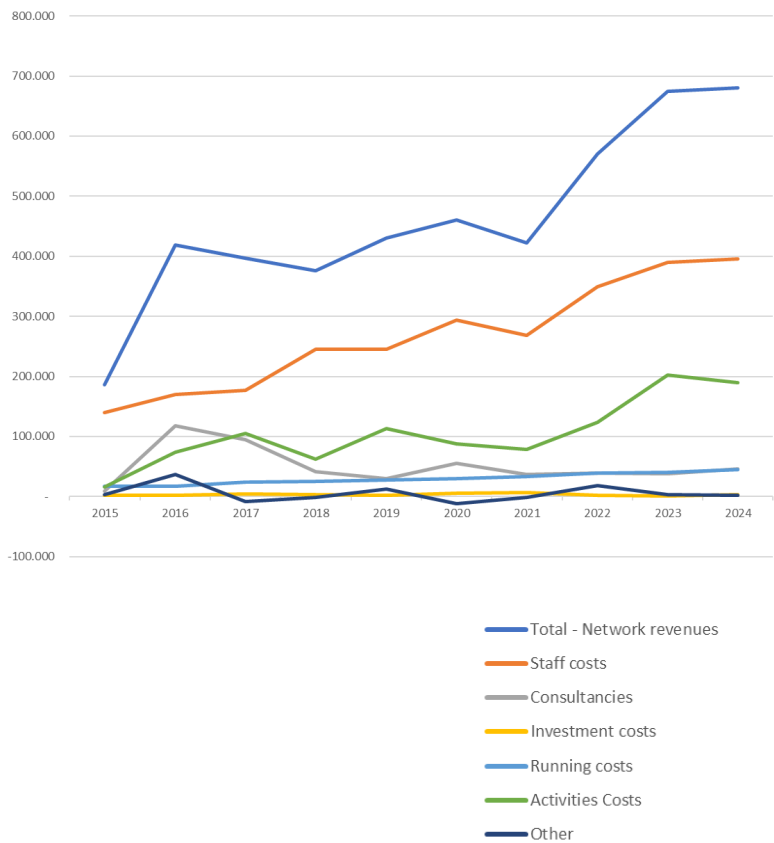

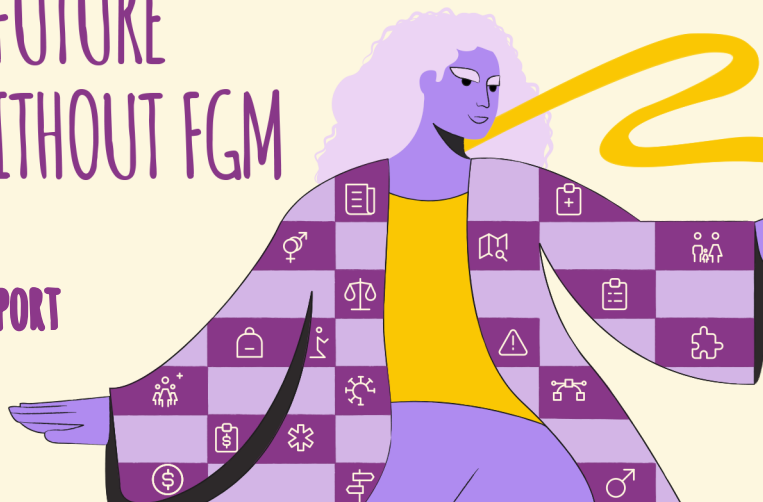
